#### **Vehicle Fleet Update**

Fleet Inventory includes **31 Non-Exempt Vehicles (25%)** and 94 Exempt Vehicles/Equipment

#### Changes to fleet inventory:

- Added two Ford Focus EVs to DPW Engineering and Fire Prevention
- > EVIP grant funding to add one more EV to Engineering
- One EV dual charging station in City Hall lot and grant funding for one more (location TBD)
- New water meter technician van will be outfitted with XLHybrid system which will save 25% on fuel
- Police Patrol: 2 Ford Fusions (mpg 23) replaced Crown Vics (mpg unknown)
- Animal Control Officer: Transit Connect (mpg 24) replaced Ford Aerostar (mpg 18)
- Schools: Dodge Caravans (mpg 20) replaced Ford passenger vans (mpg unknown)
